The projects were many and varied but included File & Print Server Migration, Maintaining & Updating the system security model, and system patching. The role was also hands on so I have been regularly working with VMWare, Hyper-V, Windows server up to 2012, SCCM, SCOM, Office 365, and Assyst. Also responsible for maintaining the DR plan in accordance with ISO27001 using CommVault for backup and restoration purposes.

Other duties include managing CommVault backups for company-wide data backup / Disaster Recovery, VMWare 5.5 hosting most operational servers, McAfee anti-virus, IBM Control-M, Logrhythm SIEM, Solar Winds, server patch management WSUS, analysis of Qualys PCI compliance reports and remedy all vulnerabilities adhering to the set ISMS controls, VM server builds, Change Management, and break-fix. This contract was initially for 3 months but a series of extensions took this to 18 months. Support, Incident, and Change Management performed using ServiceNow.
